

1. Introduction

- 1.1 Clause headings in this FIREARM CONSENT FORM are inserted for convenience only and shall not be used in its interpretation.
- 1.2 The provisions of RAM's Interpretation Schedule ("INTERPRETATION SCHEDULE") relating to interpretation shall apply and the expressions defined in that Interpretation Schedule shall bear the same meaning in this FIREARM CONSENT FORM.

2. FIREARM PROCEDURE

- This FIREARM CONSENT FORM sets out RAM's terms and conditions for Courier Services in respect of Firearm(s) and/or Ammunition (collectively "Firearms").
- 2.2 Prior to RAM providing Courier Services in respect of any Firearm, Customer shall be obliged to complete and sign RAM's FIREARM CONSENT FORM.
- 2.3 CUSTOMER shall be obliged to email and/or fax a duly signed FIREARM CONSENT FORM to the email address or fax number provided by the RAM Customer Service Agent and in the FIREARM CONSENT FORM.
- 2.4 Upon receipt of the duly signed FIREARM CONSENT FORM, a RAM Courier shall be dispatched to collect the Firearms at the address indicated on the FIREARM CONSENT FORM.
- 2.5 RAM shall take the Firearms to the relevant RAM hub where it is held in a secure area until it is redistributed for delivery as indicated in the FIREARM CONSENT FORM.

3. TERMS & CONDITIONS

- 3.1 In addition to RAM's ST&C to which this FIREARM CONSENT FORM is Annexed and which can be found on www.ram.co.za, the following terms and conditions shall apply –
- 3.1.1 all Firearms shall be transported as RAM's Economy Service (48-72hours);
- 3.1.2 neither RAM nor any TPA shall accept any Liability for the Firearm Services;
- 3.1.3 the Firearm Service shall be provided at CUSTOMER's sole risk and No insurance or indemnity shall be taken out by RAM on behalf of CUSTOMER;
- 3.1.4 all Shipping Instructions and the FIREARM CONSENT FORM must clearly be marked for the Firearm Service;
- 3.1.5 all Firearms must be supported by the duly signed Consent Form at all times;
- 3.1.6 under no circumstances may a RAM employee take on the responsibility of packaging firearms and/or ammunition on behalf of CUSTOMER;
- 3.1.7 It remains the sole responsibility of CUSTOMER to correctly package the firearms and/or ammunition before collection by a RAM courier.
- 3.2 No collection of Firearms shall take place if any of the above terms and conditions are not fully met and complied with.
