**Re: Broad-Based Black Economic Empowerment Status of RAM Transport South Africa (Pty) Ltd t/a RAM Hand-to-Hand Couriers (RAM)**

In 2017 RAM appointed Mazars East London to perform a verification of their Broad-Based Black Economic Empowerment (B-BBEE) status. Certificate Reference RAMH010-10 was issued on 08 May 2017 (copy attached). This certificate indicates that RAM is a Level 3, Value-Adding Supplier.

In terms of the Codes of Good Practice on Black-Economic Empowerment signed by the Minister of Trade and Industry on 09 February 2007:

- a Level 3 Status Level entitles purchasers to recognise 110% of their procurement from the measured entity when preparing their B-BBEE certificate
- a Value-Adding Supplier is defined as "an Entity registered as a vendor under the Value-Added Tax of 1991, whose Net Profit before Tax summed with its Total Labour Cost exceeds 25% of the value of its Total Revenue." Purchases from Value-Adding Suppliers are multiplied by 125% when preparing the purchaser's B-BBEE certificate.

When taking RAM's Level 3, Value-Adding Supplier status into account, RAM Transport South Africa (Pty) Ltd t/a RAM Hand-to-Hand Courier's effective procurement spend recognition is 137.5% (110% x 125%), which exceeds the equivalent Level 1 recognition level, for a non-value adding supplier of 135%.
