RAM'S FIREARMS TRANSPORT PERMIT

We refer to our Newsflash of 16 September 2020 relating to RAM's Annual Firearm Transport Permit.

As mentioned, RAM took the matter extremely seriously and launched an urgent Application in the High Court of South Africa (Gauteng Division, Pretoria) citing the National Commissioner of the South African Police Services, Brigadier Mabule in his capacity as Head of the Central Firearms Registry and Colonel PN Sikhakhane (in her personal capacity) and the Minister of Police as Respondents.

We are pleased to advise that RAM has been successful in the application and has received a court order instructing the First, Second and Third Respondents to issue and deliver to RAM a Transporters permit to enable it to transport firearms in terms of the provisions of section 86 of the Firearms Control Act, Act 60 of 2000 by no later than close of business 16 October 2020.

We immediately sent a representative to the SAPS and are further pleased to advise that we have in fact already obtained the Firearm Transport Permit, a copy of which is attached for ease of reference.

Accordingly, we are now able to collect and deliver any Shipments containing Firearms or Ammunition.
